Dear Compatriot,

Attached is a copy of the program of the forthcoming GACGB mini-congress to be held in Aachen, as well the list of candidatures for Executive and Editorial Board positions. To advance the course in all aspects of our union which purports to serve the interest of all compatriots resident in W. Germany, your complaints, questions, arguments, protests, votes and other contributions are not only inevitable. They constitute indeed the material which give meaning and substance to the movement. It is the central reason why we have embarked massively in contacting once more the vast majority of compatriots resident in W. Germany.

Below are pieces of important information which we hope you will take into close consideration for personal and general benefit.

Lodging

Membership

Only orderly registered members of the GACGB as prescribed by its constitution have the rights to vote during sessions - for constitutional amendments, annual programs, resolutions (other compatriots are free to debate) and for Executive and Editorial Board positions, alongside their legitimations. Accept our appel to become an orderly registered member, and enforce these rights in shaping the destiny of the GACGB to your aspirations.

Prerequisites for membership are: Being of cameroonian nationality and resident in W. Germany; annual contribution of DM 25,-; passport-sized photograph; a filled form obtainable from the adress above.(obtainable during the first day of the congress).

Already orderly registered members are herewith reminded to bring along their annual contributions for the year Jan. 01. 1991 till Dec. 31. 1991.

Participation

Orderly registered members are reminded to bring along their membership cards. All are to bring pens and papers to jot notes and for elections (ballot-papers will be prepared and provided by the Senate. Rally as many compatriots as possible, and bring enough time (punctuality) and discipline.

Soft drinks will be sold at cheap rates during sessions.

A fixed but low-rated entrance contribution will be made by all at the entrance of the gala. The Assembly will decide if the orderly registered members of this year who make their contributions for the year 1991 could be exempted from this contribution. Food and drinks will be offered at low prices during the gala. Bring many other friends to the gala.

Constitutional amendments

Whoever has proposals (member or non-member) for constitutional amendments would very much enhance the amendment process during the mini-congress by already mailing them to the above address latest Wed. 05. Dec. 1990. He/she will be mentioned if so wished, when the proposals are being made.

Whoever is in need of copies of the current GACGB-constitution before the mini-congress begins, could get them either from the regional Presidents, from Senators or could request for them from the address above. Copies will however be available during the mini-congress.

Please remember! Constitutional amendments are too important to be adopted only by a few. They can equally only have legal recognition when so done by a simple majority of the recognised quorum of the GACGB. Do come in numbers on Fr. to ensure sound and progressive decisions, and to permit legal adoption.

GACGB fundamental program

The current GACGB constitution prescribes in three of its clauses that the Senate fix and submit the annual program. The Senate however proposed (and as adopted by the mini-congress-committee) that proposals for a fundamental program be discussed within the regional associations, and then submitted to the respective Senators or mailed directly to the address mentioned above. These proposals will be compiled by the Senate and presented to the Assembly to adopt some of them. The adopted program is then to serve as a fundamental GACGB program predictable to all members during its execution by the Executive and Editorial Board, and with which each orderly registered member of the GACGB could identify him- or herself.

An allowance will be set for members of the elected Executive to add points of their individual programs to the main program from the Assembly, this in collaboration with the regional Presidents, and to be checked or controlled for constitutional conformity by the Senate.

Elections

The copies of the programs of the various candidates can unfortunately only be dispatched to the regional association boards due to financial constraints. Copies will be made available during the mini-congress. Whoever is in dire need of the programs before the mini-congress could call the number above.

In consequence of the experiences of the last years, only such compatriots who become orderly registered members till latest the first day of the mini-congress (note ! not on the day of the elections) i.e Fr. 7. Dec. could make use of their voting rights for the Executive and Editorial Board elections.

Popular voice

This aspect of the program is included to give each compatriot the chance to expose his or her opinion on the general issues of the GACGB - complaints, proposals, protests and encouragements etc. You will very much be contributing towards a smooth flow of the session if you could inform us in good time (latest Wed. 5. Dec.) of your intention of a presentation, as well as its duration.

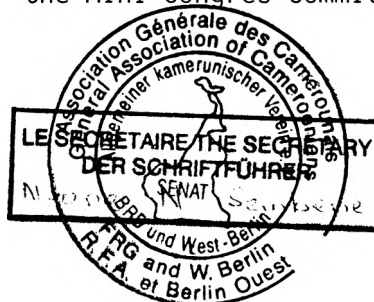
